

COPING WITH LITIGATION STRESS A RESOURCE DIRECTORY FOR OB-GYNS

The 2015 ACOG Survey on Professional Liability found that obstetrician-gynecologists experience an average of 2.6 medical liability claims during their professional careers. Research shows that physicians who are sued frequently experience feelings of shock, fear, anxiety, anger, guilt, shame, and depression. Sometimes the emotional effects are more subtle, such as a general distrust of colleagues and patients, or a feeling of isolation from friends and family members.

Because the typical liability case takes several years to resolve, coping is an ongoing, complex process in which physicians often must struggle to regain a sense of equilibrium, self-esteem, and professional mastery during an unpredictable time. This directory is intended as a starting point to help physicians face such personal and professional challenges. It contains information about resources available through state medical societies, professional liability insurance companies, and specially designed websites. The services offered by professional liability insurance companies are available to policyholders only, unless otherwise noted.

Several of the organizations listed provide literature, web-based tools, videos, referrals to professional one-on-one counseling, or other professional services. Others offer support groups facilitated by mental health professionals and/or peers who have endured a medical liability suit themselves.

Attorneys often caution physician-clients not to discuss the details of a case with anyone. Certainly, the legal and clinical aspects of a case must be kept confidential. However, to avoid feelings of isolation and increased stress, physicians are strongly encouraged to verbalize their feelings and reactions about the suit to family members, a trusted friend, or trusted colleague. If the clinical aspects of a case are to be discussed with someone other than legal counsel, this should occur only within the confines of a formal therapeutic relationship with appropriate confidentiality protections. State laws determine under what conditions and in what relationships (e.g., physician-patient, clergy-penitent) confidentiality can be maintained in the context of civil litigation.
